

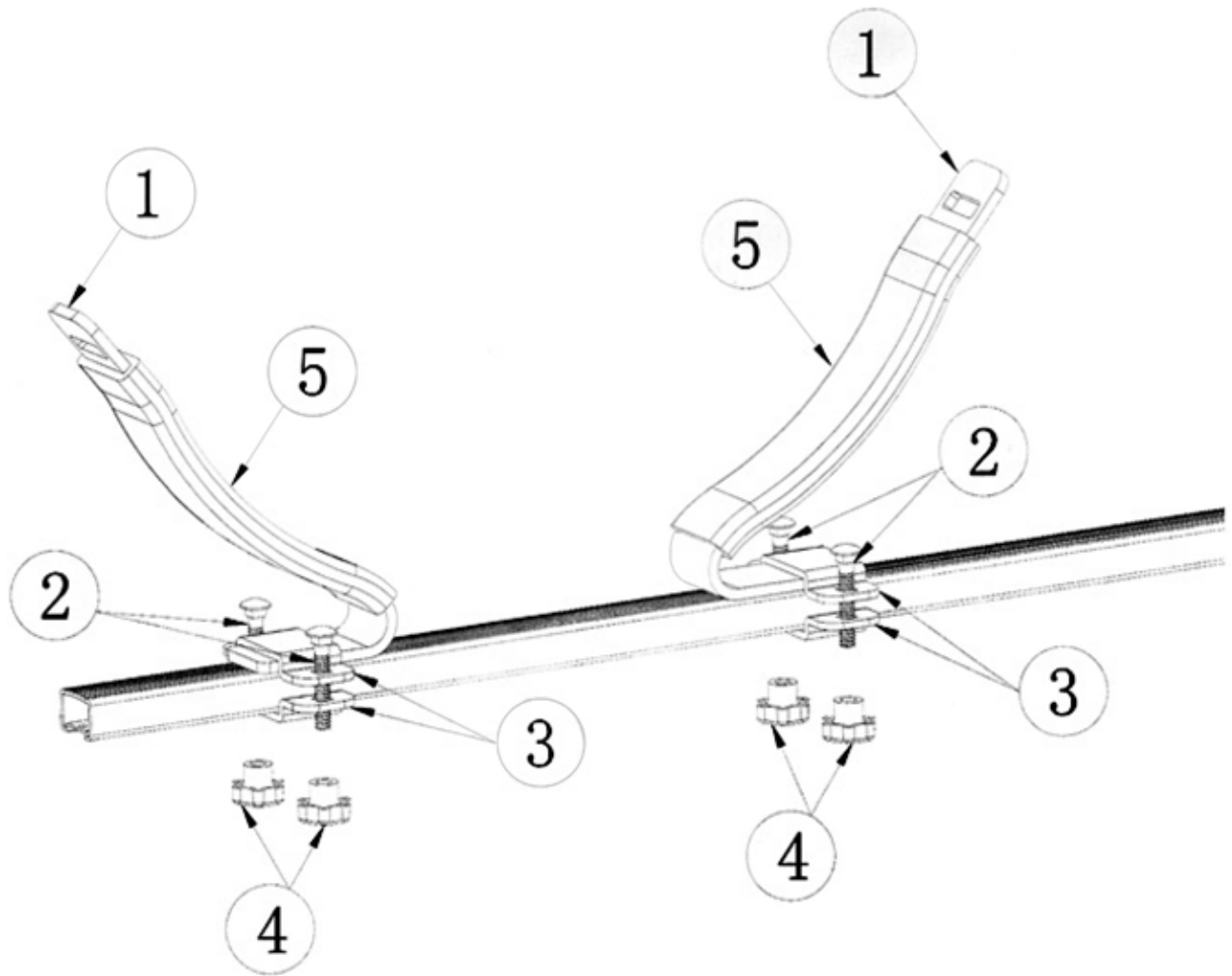
General Guidelines ⚠

- Tie down longer cargo with a bow and stern straps (sold separately).
- Attach bow and stern straps to a solid tie-down point; do not hook to plastic or flimsy bumpers.
- Secure roof cargo to the roof rack and side rails.
- Check all tie-down connections periodically on travel stops.
- The attachment of this rack is critical and beyond the control of the manufacturer. The manufacturer is not responsible for its attachment or installation. We neither guarantee nor are liable for any damages resulting from its attachment or use. Liability of this rack is limited to its purchase price.

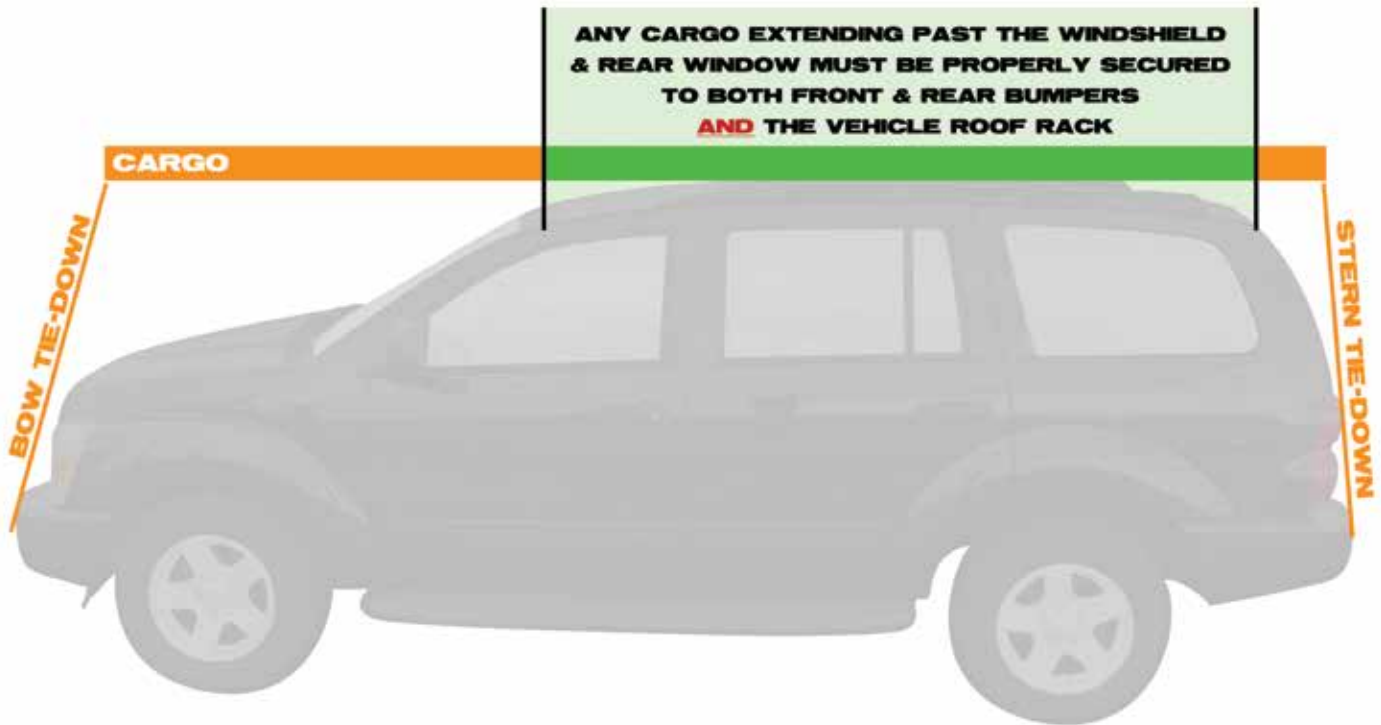

How to Properly Tie Down Roof Cargo

To prevent damage to the vehicle and/or cargo, as well as overcome updraft concerns, it is absolutely imperative to tie down the cargo extending past the vehicle windshield and rear window. A bow tie-down strap is designed to properly secure cargo to the front vehicle bumper undercarriage. The front strap counteracts air updraft forces, preventing cargo from flying upward or off the vehicle during travel. To balance the roof cargo load, a stern tie-down strap is also required, which connects the cargo to the rear bumper undercarriage.



Loading and Securing Items

Securing a roof rack to a vehicle and securing cargo or other items to the roof rack is the sole responsibility of the rack owner. It is highly important for the rack owner to follow all safety precautions to ensure the roof rack and attached cargo is properly secured for transport both for their own safety and for the safety of others on the road. Be sure to:

- Clean the roof surface before placing a rack or items for travel
- Place item directly centered onto the rack
- Attach item to the rack with rope or tie-down straps
- Attach a **front and rear** line rope or strap from the item to the **front and rear** of the vehicle (bow and stern tie-downs)
- Protect paint with a pad or cloth where the extended bow and stern lines touch the vehicle
- Recheck item and rack attachment occasionally during use

Product Warranty and Liability

GENERAL PRODUCT WARRANTY: Products purchased from the Authorized Dealer (original place of purchase) or Merchant (“Dealer”) will be free of defects in material and workmanship at the time of receipt, and will meet the specifications stated at the place of purchase transaction or online at the Dealer’s website, under normal use and service when correctly installed, operated and maintained. This product warranty is effective for the period of time stated below, unless otherwise stated in the product instructions or depicted in the product advertisement. **All Authorized Dealer warranties are NON-TRANSFERABLE** and cover only the original end purchaser. WARRANTY PERIOD: This warranty remains in force for one year from the date of the product’s accepted delivery. The Authorized Dealer offers a one year manufacturer’s warranty for most products unless otherwise specified on the product advertisement.

WARRANTY SERVICE: The Authorized Dealer will replace any defective or malfunctioning part at no charge, including payment of the shipping costs of parts or replacement product to and from the manufacturer. The purchaser is responsible for labor charges. If the product does not meet specifications as depicted in the advertisement, the Authorized Dealer will refund the full purchase price of the product.

Questions regarding the warranty on a specific product and warranty claims should be directed to the Authorized Dealer with whom the purchase transaction was made.
